## Ineligible Shareholders - Traffic Technologies Limited Rights Issue Offer

On 28 February 2018 Traffic Technologies Limited ACN 080 415 407 (**Company**) announced that it is undertaking a non renounceable pro-rata rights offer to the Company's shareholders (**Offer**). The Company is seeking to raise a total of approximately \$6.2 million from the Offer at a price of \$0.03 per Share, on the basis that no more than approximately 206,667,664 New Shares will be issued pursuant to the Offer.

The Offer is being made without a prospectus or other disclosure document in accordance with section 708AA of the Corporations Act. - the number of Shareholders with addresses in such other countries as a proportion of total Shareholders in the Company;
- (b) the number and value of the Shares those Shareholders would be offered under the Offer; and
- (c) the cost to the Company of complying with applicable legal and regulatory requirements in such other countries.

Accordingly, the Offer will not be made to shareholders resident in the jurisdiction in which your shareholding is registered.
