Letter of Chairman of the Board of Directors

Dear investors:

Welcome to the 2017 annual report of WONHE Multimedia Commerce Ltd (“Company”). It’s my pleasure on behalf of board of directors to introduce the Company’s operation result for 2017 and the Company’s future development plans.

As at 31 December 2017, the Company owns six products, including three products newly launched in 2017 (AV-500, PC-STB, advertising screens). The new products were praised by the customers leading to an increase in the popularity of the brand.

Up to December 2017, the Company's total revenue for the year was AUD 77,448,000, an increase of 15.98% compared with 2016. Revenue comes mainly from the set-top box HMC-720, commercial router YLT-300S and home set-top box PC-STB.

Products

Router Products

(1) YLT-300S

In 2017 the Company sold up to 99,320 sets of the YLT-300S commercial router (**YLT-300S**), which entered the market in June 2015, generating sales revenue of AUD 27,106,000, accounting for 35.63% of the total annual sales revenue.

The YLT-300S is capable of providing a wireless network for wireless LANs and connecting hard-coded software.

(2) YLT-300J

In 2017 the Company sold up to 94,580 sets of the YLT-300J domestic router (**YLT-300J**) which entered the market in October 2016, generating sales revenue of AUD 8,493,000, accounting for 11.16% of the total annual sales revenue.

The YLT-300J applies dual-system storage, multi-port switch, with APP-side management platform for easy management, providing solutions for home data storage. The maximum number of devices connecting with YLT-300J is up to 20 sets, and Web certification supports 10 users, aiming at consumer groups of home-based customers.

(3) YLT-100S

In 2017 the Company sold up to 46,190 sets of the YLT-100S domestic router which entered the market in March 2015, generating sales revenue of AUD 3,006,000, accounting for 3.95% of the total sales revenue of the year.

This product is a home router with an independent system, allowing customers to store information and control the number of users on the network, the web pages browsed by users, and the user's online time, aiming at consumer groups of individual customers.

(4) AV-500 (New Product in 2017)

In June 2017, the Company launched the AV-500 Power Wi-Fi router (**AV-500**) to the market. In the second half of 2017, the Company sold 35,980 sets and achieved sales revenue of AUD 1,824,000, accounting for 2.40% of the total annual sales revenue.

The AV-500 is a fully intelligent product, intelligent in such key points as storing, configuring, and transmitting information without router cables. The AV-500 is mainly aimed at individual consumer groups.

Set-Top-Box Products

(1) HMC-720

In 2017 39,090 sets of Set-top box Model HMC-720 (**HMC-720**) were sold, representing a decrease in sales of 23.74% compared with 2016. The sales generated sales revenue of A\$ 23,673,300, accounting for 31.12% of the annual sales revenue.

HMC-720 is equipped with the ability to connect to TVs and play video-on-demand, as well as the features of a game console and data storage. The HMC-720 is a home digital media solution that combines PC set-top boxes, DVDs, multimedia computers, security surveillance and video telephone.

(2) PC-STB (New Product in 2017)

In July 2017, the Company successfully launched Set-top box Model PC-STB (**PC-STB**), which represents a significant upgrade to the previous model, HMC-720. PC-STB, is a data storage, management center, control center and processing center for home devices with superior performance, low power consumption and high functionality features. The sales volume for the product has reached 21,360 sets, achieving sales revenue of AUD 11,831,000, accounting for 15.55% of total sales revenue since it entered the market, a period of less than six months.

Advertising Screen Products

At the end of 2017, the Company developed an advertising screen product which was launched in December 2017. As of 31 December 2017, the Company has sold 80 sets of the product and achieved AUD 137,000 of sales revenue which accounts for 0.18% of annual product sales revenue.

Although the sales period of the product was relatively short, the feedback of market users has been that the advertisement inserting function, the protection function of the advertising screen and flexibility owned by advertising screen products are loved and approved by users. It can be speculated that the product will occupy the market advertising screen in the future.

Beijing Wireless Network Agreement Amendments

As announced by the Company in January 2016, Shenzhen WONHE and Guangdong Kesheng Industrial Co., Ltd entered into a Cooperation Agreement to develop Wireless Network Coverage in certain designated areas of Beijing. The commercial purpose of the network was to provide a vehicle for advertising and marketing with revenue generated to be shared between the parties. Under the agreement, Shenzhen WONHE committed to provide capital as well as commercial routers and other equipment.

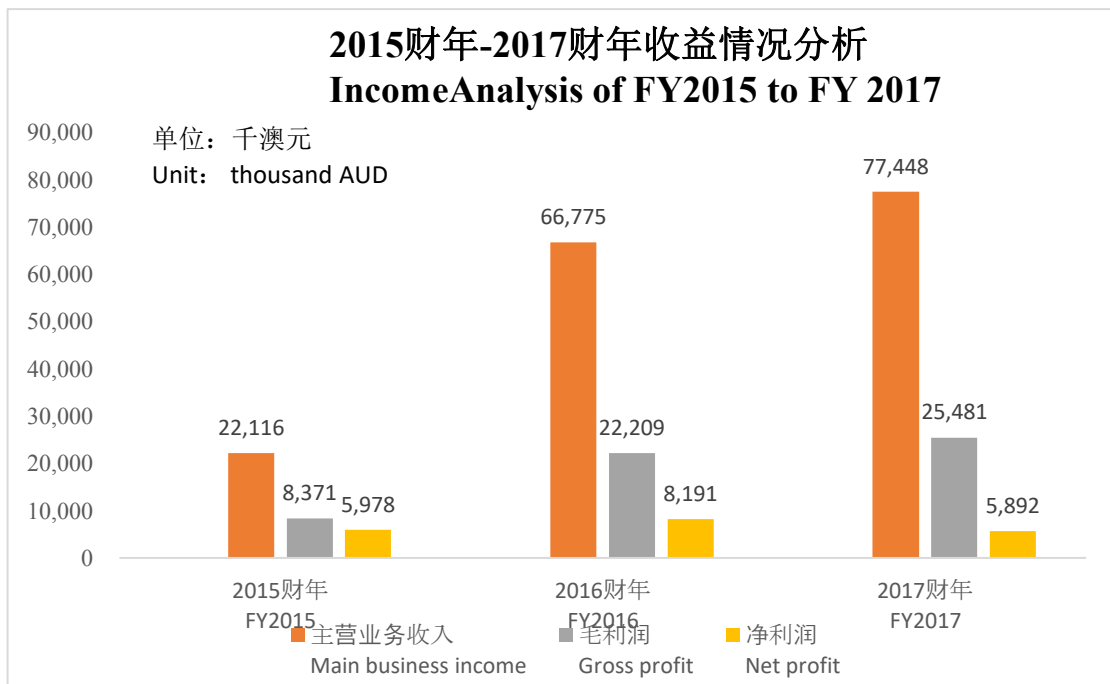
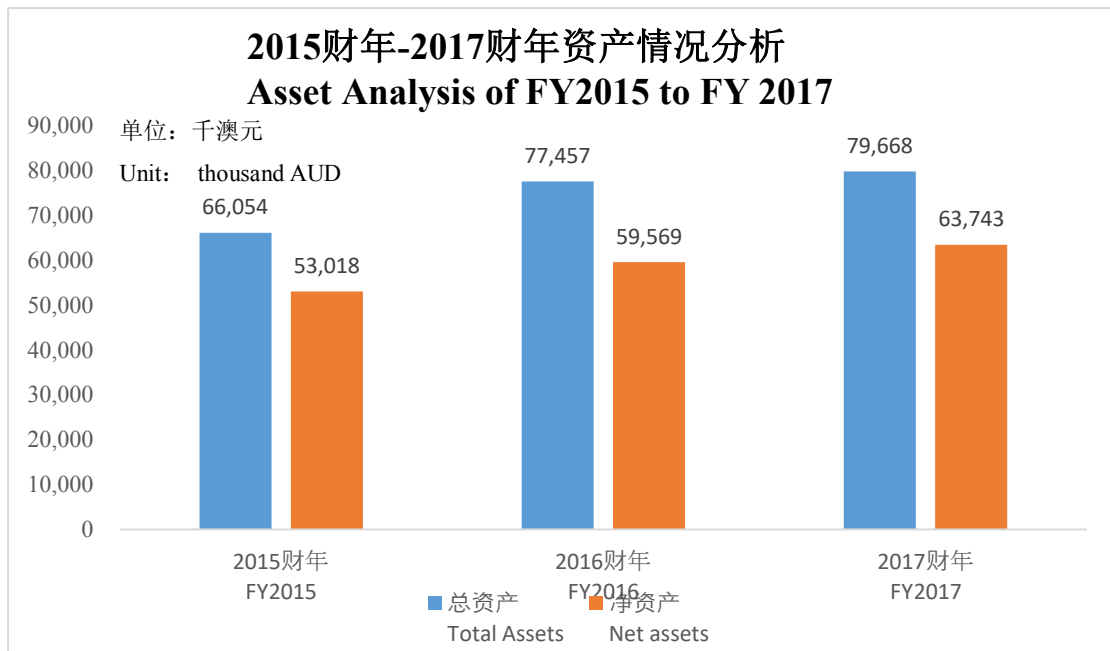
In December 2016, the Company agreed with Guangdong Kesheng Enterprise Co. Ltd to vary the agreement. Under the amended agreement the Company ceased participation in the construction and operation of the Wireless Network Coverage Project from 1 December 2017. Under the variation, the parties agreed that Shenzhen WONHE's total contribution will be repaid within three years to Shenzhen WONHE by Guangdong Kesheng, together with interest accruing at interest rate of 4.75% per

annum. However, the company continues to supply intelligent WIFI router for the project according to the original agreement.

On 29 August 2017, Shenzhen WONHE entered into an agreement with Beijing Qing Fu Asset Management Ltd, a Chinese company, for the sale and assignment of the loan receivables together with interest accruing from 1 December 2016, which was payable to Shenzhen Wonhe by Guangdong Kesheng Enterprise Co Ltd under the amended agreement. On 6 October 2017, the Company announced receipt of funds upon sale of the loan receivable.

Financial Situation

As of December 2017, the total assets of the Company is 79,668,000 Australian dollars; and the net assets is 63,743,000 Australian dollars. The total operating income is 77,448,000 Australian dollars, in which the income of intelligent routers is 40,429,000 Australian dollars accounting for 52.20% of the total income; the income of set top box is 35,504,000 Australian dollars accounting for 45.84% of the total income; the income of advertising screen is 137,000 Australian dollars accounting for 0.18% of the total income; the other income is 1,378,000 Australian dollars accounting for 1.78% of the total income. The net profit is 5,892,000 Australian dollars, and the net interest rate is 7.61%.



Looking forward to 2018, the Company shall continue to maintain high efficiency and steady development. The future development of the Company is focused on:

1. Update and replacement of existing products.

The Company plans to reduce the production of YLT-100S products gradually in 2018 until the products are out of the market. This is due to technical renovation of electronic products and market feedback.

2. Expanded production of star products.

The Company will expand the production of the products with higher sales and better evaluation, including router product AV-500, set-top box products PC-STB, advertising screen and other new products. The Company will expand its market share with high quality products, in order to achieve the business objectives in the new year.

3. Increase of research and development investment.

The Company plans to continue to increase investment in research and development in 2018. The Company will expand product types, research and development projects include: Android intelligent phones, integrated personal computers, minicomputers and so on. The Company will expand the business of company and develop diversified products. The Company will also improve the competitiveness of the company and expand the market shares of company.

4. Strong launch of new products.

Following feedback from Market Research, combined with the public's expectations, the Company will develop a network HD player, which not only has the TV look back function also supports the suspension and cache, and support for Android Player with 3D Blu-ray Decoding. Making the products be the necessary choice of users who like the blue-ray 3D and pursue the stereoscopic vision.

In 2018, the Company plans to launch 2 set-top box products to further make up for customer needs in the segment market so as to further achieve the integrity of WONHE's set-top box products chains.

5. Positive Expansion of Sales Channels.

In 2018, the Company aims to increase the publicity of its new products in different ways and expand its product sales channels to form a nationwide sales network with Guangdong at its center, to promote the Company and its products all over the country. The Company will use high-quality products and diversified services to win more customers trust, to increase sales revenue, to improve the competitiveness of new products and to create a unique quality company brand and company image.

On behalf of the board of directors, I look forward to your participation and contribution in the Company's ongoing development and thank you for your support.

Principal Activities

Wonhe Multimedia Commerce Ltd was incorporated 27 July 2015. In August 2015, through a Share Sale Agreement with World Win International Holding Ltd ("World Win"), the Company acquired 100% of the shares in Kuayu International Holdings Group Ltd ("Kuayu"), a company incorporated in Hong Kong and which owns and operates the WONHE business in China via its Chinese subsidiaries.

The WONHE operating subsidiary company is Shenzhen WONHE Technology Co., Ltd ("Shenzhen WONHE"), a company incorporated in China. Shenzhen WONHE derives revenues from the sale of the Commercial Routers, receives a commission from the retail sales to users who purchase products from a retailer via the WONHE App and derives revenue from targeted advertisements. Shenzhen WONHE also owns the user data that is compiled and aggregated from its Commercial Routers.

The WONHE business operates solely within the People's Republic of China.

Operating Results and Financial Position

During the period the Group made a profit of \$5.892 million (2016: \$8.191 million) after a tax expense of \$2.637 million (2016: \$2.414 million). The result for the year includes a finance charge of \$4.166 million arising from the discounting for risk factors of the loan to Guangdong Kesheng Enterprise Co., Ltd. This loan was sold during the year for \$22.879 million.

As a result of operations and sale of the loan the Group's net assets have increased to \$63.743 million (2016: \$59.569 million). Current assets increased to \$77.767 million (2016: \$60.384 million, with gross assets increasing to \$79.668 million (2016: \$77.457 million). The Group generated \$11.640 million in cash from operations (2016: \$1.577 million), with cash and cash equivalents increasing in total during the year to \$70.468 million (2016: \$38.672 million).

During the previous year, Shenzhen WONHE entered into an adjusted loan agreement with Guangdong Kesheng Enterprise Co., Ltd ("Guangdong Kesheng"). The agreement set out the terms for repayment of the RMB175,755,641 (\$35.164 million) previously invested into a Guangdong Kesheng project in three equal instalments with the unpaid proportion accruing interest at a rate of 4.75% pa. At 31 December 2016 the repayments were discounted back to present value using a 20% discount rate, which resulted in the recognition of a finance expense of \$8.127 million at 31 December 2016, and a further \$4.166 million in finance costs during the current year.

In the event of the sale of the loan Shenzhen WONHE received RMB119,513,836 to fully assign the loan to a third party. This provided the Group with certainty over its cash flows, enabling focus on its core business.

Dividends

On 31 May 2017, the Company paid a dividend of 0.5882 cents per share. The dividend was announced based on the 2016 results. No dividend for the 2017 financial results has been proposed or paid.

Significant Change in State of Affairs

Other than the sale of the Group's loan receivable, as outlined above, there were no other significant changes in the state of affairs of the Group during the financial year.

After Balance Date Events

The Board is not aware of any matter or circumstance not otherwise dealt with in these financial statements that has significantly or may significantly affect the operation of the Group, the results of those operations, or the state of affairs of the Group in subsequent financial years.

Future Developments

The Group's strategic focus remains: -

- The Expansion Production of Star Products

Combined with the required information of product sales and market feedback in 2017, the Group will expand the production of the products with higher sales and better evaluation, including router product AV-500, set-top box products PC-STB, advertising screen and other new products. The Group will use the product development and enhancement to expand its market share with high quality products, in order to achieve the business objectives in the coming year;

- The Update and Replacement of the Existing Products

Due to the continued technical renovation of electronic products and market feedback, the company plans to phase out the production of YLT-100S products gradually in 2018 until the products are removed from the market, enabling focus on the Star products.

- The Outstanding Increase of Research and Development Investment

The Group plans to continue to increase research and development investment and strengthen its research and development activities in the year of 2018. The Group will expand the product types, the specific research and development projects are as follows:

- Android intelligent phones,
- integrated personal computers,
- minicomputers, etc.,

The Group will expand the business through research and development and through diversified products. The Group will also improve the competitiveness and expand market share through effective product development;

- Strong New Product Launch

Based on feedback received from the Market Research Report, the Group will develop a network HD player, which not only has the TV look back function but also supports suspension and cache, whilst supporting Android Player with 3D Blu-ray Decoding. This will make the products the choice of users who like the blue-ray 3D and pursue the stereoscopic vision. In 2018, the Group plans to launch 2 set-top box products to further meet customer needs in the market sector, further achieving the integrity of WONHE's set-top box products chains.

- Positive Expansion of Sales Channels

In 2018, the Group will increase the marketing activities of new products to expand its product sales channels and form a nationwide sales agent network taking Guangdong as the centre. This will promote the Group as a nationwide entity enabling promotion of its products throughout the country. The Group will focus on high-quality products and diversified services and promote the Group as a supplier of high quality products, increasing the Group's brand identity to win more customer trust, improve the competitiveness of new products, increase market penetration, and, by extension, sales revenue.

Business Risk

The material risks faced by the Group that are likely to influence the financial prospects of the Group, and how the Group manages these risks include: -

1. Economic Conditions

The Group's revenues may be negatively influenced by changes in regional or local economic variables and consumer confidence in China. Unemployment rates, levels of personal disposable income and regional or local economic conditions may adversely affect consumer spending, decreasing demand for the WONHE products. Based on the views of prominent economic commentators, the Directors do not anticipate any significant slowdown in the current market economies but are continuing to investigate the potential of the Group to expand sales into emerging economies and to diversify into other products.

2. Technological Obsolescence

Given the rapidly changing environment in which the Group operates, this could have an impact on the Group's financial results. The Group addresses this risk through investment in research and development and by constantly monitoring market trends and developments. With competitors constantly seeking to enter the market with improved designs, this risk is likely to increase in the future.

3. The Company is exposed to various economic, environmental and social sustainability risks. The Company has adopted a Risk Management Policy to assist with management of these risks, which is available on the Company's website.

Indemnity and Insurance of Officers

The Company has indemnified the directors and executives of the Company for costs incurred, in their capacity as a director or executive, for which they may be held personally liable, except where there is a lack of good faith. During the financial year, the Company paid a premium in respect of a contract to insure the directors and officers of the Company against a liability to the extent permitted by the *Corporations Act 2001*. The contract of insurance prohibits disclosure of the nature of liability and the amount of the premium.

Indemnity and Insurance of Auditor

The Company has not, during or since the financial year, indemnified or agreed to indemnify the auditor of the Company or any related entity against a liability incurred by the auditor. During the financial year, the Company has not paid a premium in respect of a contract to insure the auditor of the Company or any related entity.

Environmental Regulations

The operations of the Group in Australia and PRC are not subject to any particular or significant environmental regulation under a law of the Commonwealth or of a State or Territory in Australia or PRC.

Shares under Option or Issued on Exercise of Options

The Company has no shares under option. No shares were issued during the year upon the exercise of options.

Proceedings on Behalf of the Company

No person has applied for leave of the Court under Section 327 of the *Corporations Act 2001* to bring proceedings on behalf of the Company or intervene in any proceedings to which the Company is a party for the purpose of taking responsibility on behalf of the Company for all or any part of those proceedings. The Company was not a party to any proceedings during the year.

REMUNERATION REPORT (AUDITED)

The remuneration report, which has been audited, outlines the Director and executive remuneration arrangements for the Group, in accordance with the requirements of the *Corporations Act 2001* and its Regulations.

A. Principles Used to Determine the Nature and Amount of Remuneration

The performance of the Group depends upon the quality of its Directors and Executives. To prosper, the Company must attract, motivate and retain highly skilled Directors and Executives. To that end, the Company embodies the following principles in its remuneration framework:

- Provide competitive rewards to attract high calibre executives;
- Focus on creating sustained shareholder value;
- Placing a portion of executive remuneration at risk, dependent upon meeting predetermined performance benchmarks; and
- Differentiation of individual rewards commensurate with contribution to overall results and according to individual accountability, performance and potential.

The Board's policy for determining the nature and amount of remuneration for Key Management Personnel ("KMP") for the Group is based on the following: -

- The remuneration policy is to be developed and approved by the Board after professional advice is sought from independent external consultants (where applicable).
- All KMP receive a base salary (which is based on factors such as length of service and experience), superannuation, fringe benefits and performance incentives.
- Performance incentives (in the form of a cash bonus) are generally only paid once predetermined key performance indicators (KPIs) have been met.
- No share based/options incentives are offered to KMP.
- The Board, which also serves as the remuneration committee, reviews the remuneration packages annually by reference to the Group's performance, executive performance and comparable information from industry sectors.

All remuneration paid to KMP is valued at the cost to the Group and expensed.

KMP or closely related parties of KMP are prohibited from entering hedge arrangements that would have the effect of limiting the risk exposure relating to their remuneration. In addition, the Board's remuneration policy prohibits Directors and KMP from using the company's shares as collateral in any financial transaction.

Engagement of remuneration consultants

During the year, the Company did not engage any remuneration consultants.

Remuneration Structure

The structure of Non-Executive Director, Executive Director and Senior Manager remuneration is separate and distinct.

Non-Executive Director Remuneration

The Board's policy is to remunerate Non-Executive Directors at market rates for time, commitment and responsibilities. The Board determines payments to the non-executive directors and reviews their remuneration annually, based on market practice, duties and accountability. Each Director receives a fee for being a Director of the Company.

1. BASIS OF PREPARATION

These financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards, Australian Accounting Interpretations and the *Corporations Act 2001*, as appropriate for profit oriented entities.

The financial statements cover the Company and its controlled entities as a group for the financial year ended 31 December 2017. The Company is a company limited by shares, incorporated and domiciled in Australia.

Separate financial statements for the Company as an individual entity are no longer presented as a consequence of a change to the *Corporations Act 2001*, however limited financial information for the Company as an individual entity is included in Note 17. Except for the Statement of Cash Flows, the financial statements have been prepared on the accruals basis.

The following is a summary of material accounting policies adopted by the Group in the preparation and presentation of the financial statements. The accounting policies have been consistently applied, unless otherwise stated.

The financial statements were authorised for issue by the Directors on 2 April 2018.

The Group's principle activities are the design and development of software and hardware technology products for distribution in the People's Republic of China.

(a) Basis of Preparation of the Financial Statements

Compliance with IFRS

The financial statements comply with International Financial Reporting Standards (IFRS) as issued by the International Accounting Standards Board (IASB).

Historical Cost Convention

The financial statements have been prepared under the historical cost convention, modified where appropriate by the measurement of fair value of selected non-current assets. All amounts are presented in Australian dollars unless otherwise noted.

(b) Principles of Consolidation

The consolidated financial statements are those of the Group, comprising the parent entity and its controlled entities as defined in Accounting Standard AASB 10 '*Consolidated Financial Statements*'. Control is achieved when the Company:

- Has power over the investee;
- Is exposed, or has rights, to variable returns from its involvement with the investee; and
- Has the ability to use its power to affect its returns.

The Company reassess whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Details of the controlled entities are contained in Note 18(b).

Financial statements for controlled entities are prepared for the same reporting period as the parent entity. Controlled entities are fully consolidated from the date on which control is transferred to the Group and cease to be consolidated from the date on which control is transferred out of the Group. Adjustments are made to bring into line any dissimilar accounting policies which may exist.

All inter-company balances and transactions, including any unrealised profits or losses have been eliminated on consolidation.

Non-controlling interests in the equity and results of the entities that are controlled are shown separately in the consolidated financial statements.

(c) Comparatives

Where necessary, comparative information has been reclassified and repositioned for consistency with the current year's disclosures.

(d) Rounding of amounts

The company is of a kind referred to in ASIC Corporations (Rounding in Financial/Directors' Reports) Instrument 2017/191 and in accordance with that Class Order, amounts in the financial statements have been rounded off to the nearest thousand dollars, or in certain cases, to the nearest dollar.

2. CRITICAL ACCOUNTING ESTIMATES AND JUDGMENTS

The Group makes certain estimates and assumptions concerning the future, which, by definition, will seldom represent actual results. The estimates and assumptions that have a significant inherent risk in respect of estimates based on future events, which could have a material impact on the assets and liabilities in the next financial year, are discussed within the relevant notes to the financial statements.

3. RESTATEMENT OF COMPARATIVES

Correction of prior period error – Balance of Loan Advanced at 31 December 2016

Subsequent to the issue of the Annual Report for the year ended 31 December 2016, a review of the Group's Financial Report and auditor's file was undertaken by the Australian Securities and Investments Commission. During the review it was noted that there was error contained in the discounting calculation in relation to the Loan Advanced by the Group to Guangdong Kesheng Enterprise Co., Ltd. It was noted that the Group had discounted the loan balance by a factor of 20% to incorporate specific risks associated with the amount receivable and the timing of the repayments. However, in calculating the discounted value of the repayments, it was noted that discounting was applied incorrectly. The comparatives have been restated to reflect the correctly discounted Loan Advanced balance at 31 December 2017.

The effects of the correction of this error on the comparative year figures are as follows: -

- The total loan advance balance was reduced by \$5.407 million, and the Statement of profit or loss for the year ended 31 December 2016 reduced by the same amount.
- Current Loan Advanced balance was reduced by \$0.492 million and Non-current Loan Advanced was reduced by \$4.915 million.

Statement of profit or loss and other comprehensive income

When there is a restatement of comparatives, it is mandatory to provide a statement of profit or loss and other comprehensive income for the comparative year.

Statement of financial position

When there is a restatement of comparatives it is mandatory to provide a third statement of financial position at the beginning of the earliest comparative period. However, as the adjustments impact only the balance as at 31 December 2017. Accordingly, the Group has elected not to show the 1 January 2016 statement of financial position.

4. FINANCIAL RISK MANAGEMENT, OBJECTIVES AND POLICIES

The Group's principal financial instruments comprise receivables, payables, cash and short term deposits.

The Group manages its exposure to key financial risks, including interest rate and currency risk in accordance with the Group's financial risk management policy. The objective of the policy is to support the delivery of the Group's financial targets whilst protecting future financial security.

The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, price risk, credit risk and liquidity risk. The Group uses different methods to measure and manage different types of risk to which it is exposed. These include monitoring levels of exposure to interest rate and foreign exchange risk and assessments of market forecasts for interest rate, foreign exchange and commodity prices. Aging analyses and monitoring of specific credit allowances are undertaken to manage credit risk, liquidity risk is monitored through the development of future rolling cash flow forecasts.

The Board reviews and agrees policies for managing each of these risks as summarised below.

(a) Significant accounting policies

Classification

The Group classifies its financial instruments in the following categories: financial assets at fair value through profit or loss, loans and receivables, held-to-maturity investments, and available-for-sale financial assets. The classification depends on the purpose for which the investments were acquired. Management determines the classification of its financial instruments at the time of initial recognition. The Group does not designate any interests in subsidiaries, associates or joint ventures as being subject to the requirements of Accounting Standards specifically applicable financial instruments. Accordingly, such interests are accounted for on a cost basis.

At the reporting date the Group's financial instruments were classified within the following categories: -

Loans and Receivables

Loan and receivables are measured at fair value at inception and subsequently at amortised cost using the effective interest rate method.

Financial Liabilities

Financial liabilities include trade payables, other creditors and loans from third parties including inter-company balances and loans from or other amounts due to Director-related entities.

Non-derivative financial liabilities are recognised at amortised cost, comprising original debt less principle payments and amortisation.

Impairment

At the end of each reporting period, the Group assesses whether there is objective evidence that a financial asset has been impaired. A financial asset (or a group of financial assets) is deemed to be impaired if, and only if, there is objective evidence of impairment as a result of one or more events (a "loss event") having occurred, which has an impact on the estimated future cash flows of the financial assets(s).

In the case of financial assets carried at amortised cost (including loans and receivables), a separate allowance account is used to reduce the carrying amount of financial assets impaired by credit losses. After having taken all possible measures of recovery, if management established that the carrying amount cannot be recovered by any means, at that point the written off amounts are charged to the allowance account or the carrying amount of impaired financial assets is reduced directly if no impairment amount was previously recognised in the allowance account.

When the terms of financial assets that would otherwise have been past due or impaired have been renegotiated, the Group recognises the impairment for such financial assets by taking into account the original terms as if the terms have not been renegotiated so that the loss events that have occurred are duly considered

(b) Risk Exposures and Responses

(i) Interest Rate Risk

Exposure to interest rate risk arises on financial instruments whereby future a future change in interest rates will affect future cash flows or the fair value of the fixed rate financial instruments. The Group is also exposed to earnings volatility on floating rate instruments. As a result of operations in China the Group's statement of financial position can be affected significantly by movements in the RMB/AUD exchange rates. The Group does not have a formal policy or strategy implemented to mitigate the effects of its foreign currency exposure. As the majority of the Group's operations occur within controlled entities located within China, foreign currency risk relating to the reported values of financial instruments is considered to be an inherent risk of the Group.

(b) Significant Accounting Policy - Revenues

Revenue arises from the sale of goods and services. It is measured by reference to the fair value of consideration received or receivable, excluding sales taxes, rebates, and trade discounts. Any consideration deferred is treated as the provision of finance and is discounted at a rate of interest that is generally accepted in the market for similar arrangements. The difference between the amount initially recognised and the amount ultimately received is interest revenue.

The Group often enters sales transaction involving a range of the Group's products and services, for example for the delivery of hardware, software and related after-sales service. The Group applies the revenue recognition criteria set out below to each separately identifiable component of the sales transaction in order to reflect the substance of the transaction. The consideration received from these multiple-component transactions are allocated to the separately identifiable component in proportion to its relative fair value.

Revenue from the sale of goods is recognised when the significant risks and rewards of ownership of the goods have passed to the buyer and the costs incurred or to be incurred in respect of the transaction can be measured reliably. Risks and rewards of ownership are considered passed to the buyer, generally, when the buyer has taken undisputed delivery of the goods.

Revenue from the sale of goods with no significant service obligation is recognised on delivery as this corresponds to the transfer of significant risks and rewards of ownership of the goods and the cessation of all involvement in those goods.

Where significant tailoring, modification or integration is required as a part of the sales agreement, revenue is recognised based on estimates of stage of completion or, where that is not possible, to the extent that recoverable costs are recognised.

When goods are sold together with customer loyalty incentives, the consideration receivable is allocated between the sale of goods and sale of incentives based on their fair values. Revenue from sales of incentives is recognised when incentives are redeemed by customers in exchange for products supplied by the Group.

Revenue is recognised net of applicable goods and services taxes.

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

Dividend revenue is recognised when the Group's right to receive the payment is established.

Current income tax assets and/or liabilities comprise those obligations to, or claims from, the Australian Taxation Office (ATO) and other fiscal authorities relating to the current or prior reporting periods that are unpaid at the reporting date. Current tax is payable on taxable profit, which differs from profit or loss in the financial statements. Calculation of current tax is based on tax rates and tax laws that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and liabilities are calculated, without discounting, at tax rates that are expected to apply to their respective period of realisation, provided they are enacted or substantively enacted by the end of the reporting period.

A balance sheet approach is adopted under which deferred tax assets and liabilities are recognised for temporary differences between the tax bases of assets and liabilities and their carrying amounts in the financial statements. No deferred tax asset or liability is recognised if it arose in a transaction, other than a business combination, that at the time of the transaction did not affect either accounting or taxable profit or loss.

Deferred tax assets are recognised for temporary differences and unused tax losses only when it is probable that future taxable amounts will be available to utilise those temporary differences and losses. Current and deferred tax balances attributable to amounts recognised directly in equity are also recognised directly in equity.

(g) Critical accounting estimates and judgments

The benefit of the tax losses has not been brought to account at 31 December 2017 because the directors do not believe it is appropriate to regard realisation of the deferred tax asset as being probable at this point in time. These tax losses are also subject to final determination by the Taxation authorities when the Group derives taxable income. The benefits will only be realised if:

- (a) The Company derives future assessable income of a nature and of an amount sufficient to enable the benefit of the deduction for the losses to be realised;
- (b) The Company and its subsidiaries continue to comply with the conditions for the deductibility imposed by law; and
- (c) No changes in the tax legislation adversely affect the Company and its subsidiaries in realising the benefit of the losses.

Australian tax losses are subject to further review by the consolidated entity to determine if they satisfy the necessary legislative requirements under the Income Tax legislation for the carry forward and recoupment of tax losses.

The discount rate applied was 20%, which had the effect of reducing the receivable balance by \$8.127 million and resulted in the recognition of a finance cost of a corresponding amount.

This discount rate was estimated using management's judgements of the risk factors, and was, necessarily, subjective. During the current year the Group discounted the loan further to reflect its recoverable value based on market factors, before disposing of the loan to a third party. A further cost of \$4.166 million was reflected in the financial report for the period. The estimate of the discount rate, and related interest cost, at 31 December 2016 impacted the carrying value of the loan and the subsequent finance cost recognised at 31 December 2017. Had the estimate of the discount at 31 December 2017 varied, the carrying value at that date would have varied, and the finance cost recognised during the year ended 31 December 2017 would have varied.

In October 2005, the National Administration of Foreign Exchange published the Notice of Domestic Residents Financing through Specific Companies Overseas and Returned Investments of Foreign Exchange Administration Issues (*Document 75*), which came into operation on November 1, 2005. Under Document 75, PRC residents must apply for overseas foreign exchange investment clearance from the PRC Foreign Exchange Administration and Foreign Exchange Bureau in order to invest in specific types of overseas companies. While the Chinese shareholders in the Company have applied for, and received, approval for foreign investment under Document 75, there is no guarantee that such approval will not be restricted or lapse in the future.

Current Chinese regulations allow the Company's China Subsidiaries to pay dividends to the Company, but this is subject to applicable regulatory requirements. In addition, the Company has no direct business operations in China, other than indirect ownership of subsidiaries, which may limit the payment of dividends to the Company.

Cash transfers from Chinese subsidiaries to their parent companies outside China are subject to government control of currency conversion, and the Company may receive the majority or all of its revenues in RMB. Under the current corporate structure of the WONHE group, the Company's income is primarily derived from its Chinese Subsidiaries. Under existing Chinese foreign exchange regulations, payment of current account items, including profit distributions, interest payments and expenditures from trade-related transactions can be made in foreign currency without prior regulatory approval by complying with certain procedural requirements.

As profit and dividends are current account items, the profit and dividends generated in China may be paid to shareholders outside China without prior approval, as long as the Company complies with certain procedural requirements. However, the Chinese government also may, at its discretion, restrict access in the future to foreign currencies for current account transactions. If changes to the foreign exchange control system prevents the Company's Chinese Subsidiaries from obtaining sufficient foreign currency to satisfy their currency demands, they may not be able to pay dividends in foreign (non-RMB) currencies to the Company.

Any inability to obtain the requisite approval for converting RMB into foreign currencies, any delays in obtaining such approval or future restrictions on currency exchange may restrict the ability of the Company's China Subsidiaries to remit sufficient foreign currency to pay dividends or other payments to the Company, or otherwise satisfy its obligations.

The Group does not expect the adoption of the new Standard to have a material impact on its classification and measurement of the financial assets and liabilities, or its results on adoption of the new impairment model. The Group has decided not to early adopt AASB 9.
- AASB 15 establishes a comprehensive framework for determining whether, how much and when revenue is recognised. It replaces existing revenue recognition guidance, including IAS 18 '*Revenue*', IAS 11 '*Construction Contracts*', and IFRIC 13 '*Customer Loyalty Programmes*'. IFRS 15 is effective for annual reporting periods beginning on or after 1 January 2018, with early adoption permitted. The Group

This standard becomes mandatory for the Group's 31 December 2019 financial statements. The Group has decided not to early adopt AASB 16, this is in line with the requirement to adopt AASB 15 at the same time. Once adopted, the structure of cash flows and the presentation of the balance sheet and income statement will change, with no material impact on overall cash flows and net profits.

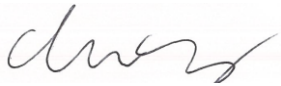
