Request for Trading Halt: P2P Transport Limited (ASX: P2P)

Pursuant to ASX Listing Rule 17.1, P2P Transport Limited (ASX: P2P) (P2P) requests an immediate trading halt be granted by ASX Limited (ASX) with respect to its fully paid ordinary shares from the commencement of trading on Monday, 14 May 2018.


The trading halt is requested in connection with a material transaction by P2P.
