On 27 March 2018, the Company announced the successful subscription of a fully subscribed private placement of 50,000 Unsecured Mandatorily Convertible Notes to raise A\$5M. 45,500 Notes were issued on 3 April 2018.

The Notes are subordinated unsecured debt obligations of the Company and are perpetual subject to Conversion. Any time after 19 April 2018, the Investor may elect by giving not less than 2 Business Days' notice to the Issuer to require that the Company convert all of the Investor's Notes into Ordinary Shares at the Conversion Price (**Maturity Conversion**).

Not later than 2 Business Days after the Issuer announces that its directors have recommended a takeover bid in relation to the Issuer or a scheme of arrangement in relation to the Issuer, each Note shall convert into Ordinary Shares at the Conversion Price (also, **Maturity Conversion**).

On Maturity Conversion, the Notes will convert into Ordinary Shares at \$0.40 per Share unless on or before 30 September 2018 a **Qualifying Capital Raising** has been completed, in which event the Notes will convert into Ordinary Shares at the greater of:

- (a) \$0.23 per Ordinary Share; and
- (b) the lesser of:
 - (i) \$0.40 per Ordinary Share; and
 - (ii) an amount equal to a 20% discount to the issue price per Ordinary Share (or conversion price of convertible securities) issued under a **Qualifying Capital Raising**,
