NON-RENOUNCEABLE RIGHTS ISSUE OF SHARES AND OPTIONS CHANGE OF OFFER PRICE TO 3.2 CENTS

After consultation with ASX and to comply with the requirements of listing rule 7.11.2, the Company has changed the offer price under the non-renounceable pro rata entitlement offer to shareholders (**Rights Offer**) announced on 14 June 2018 from 3.25 cents per share to 3.2 cents per share, to now raise up to approximately \$1,499,537.

All other terms and conditions for the Rights Offer will remain the same.

The Company will shortly issue an updated Rights Offer document together with updated notices to shareholders and optionholders.
