Covata is pleased to announce it has signed its first two ITAR ("International Traffic in Arms Regulations") customers in the U.S.

DSM Dyneema, a global supplier of next generation armour, and SAES Getters, an advanced functional materials group, have been launched on Covata's SafeShare platform deployed on Amazon's AWS GovCloud in the United States. The initial contract value of these first ITAR related deals is US\$101K (A\$136K) and is sold on a perpetual basis with maintenance and support included for the first three years.

Covata has recently deployed its proven SafeShare solution on AWS GovCloud to provide secure data services to businesses subject to ITAR and Export Administration Regulations compliance.

AWS GovCloud provides cloud Infrastructure-as-a-Service physically located in the United States and where access by Amazon personnel is limited to US citizens, thereby allowing qualified companies to transmit, process, and store data subject to ITAR restrictions. The combination of AWS GovCloud and the advanced security and permissions management capabilities of SafeShare allow businesses to embrace the cloud while managing the complex access requirements for ITAR.

Collectively, these sales demonstrate the benefits of Covata utilising its sales teams across regions in selling each of our products in their respective markets.

Covata's Chief Commercial Officer, Derek Brown, said: "We have focused our sales and marketing on developing use cases for customers in key markets and industries impacted by ITAR. Our SafeShare for ITAR offering is an important and successful step in demonstrating the value of our solutions for highly-regulated industries across the globe."
