INVESTMENT MANAGER

The Investment Manager of the Company's investment portfolio is Franklin Templeton Investments Australia Ltd. The Company's portfolio is managed in accordance with the investment philosophy of the Templeton Global Equities Group ("Templeton"), which forms part of the Franklin Templeton Investments group, a large U.S. based investment management organisation. Templeton is one of the pioneers in global investing and its successful investment philosophy has been refined over more than 60 years. The Templeton investment process endeavours to identify undervalued securities through fundamental company analysis, using a global focus and a long term investment horizon.

INVESTMENT APPROACH

Templeton's time-tested investment approach is based on its philosophy of value, patience and bottom-up stock selection. Templeton focus on the rigorous analysis of individual stocks across geographic borders and seek to identify companies trading at significant discounts to Templeton's estimates of future earnings power, cash flow generation and/or asset value. As independent thinkers with strong conviction in their investment ideas, they take an unconstrained approach to finding value.

QUARTERLY MARKET REVIEW

Global equity markets gained in Q2 2018 in Australian dollar terms. Developed-market stocks advanced ahead their emerging- and frontier-market peers, which generally suffered fairly steep declines.

Growth continued to outperform value during the reporting period (6.3% return for the MSCI ACWI Growth Index versus 2.7% for MSCI ACWI Value in AUD terms) amidst escalating trade tensions that unnerved investors. Performance trends remained broadly consistent with recent periods, with a few exceptions.

Growth-oriented technology shares and dominant US equities maintained their long-running leadership, while energy extended more recent gains as supply concerns in Venezuela and Iran and a smaller-than-expected output increase by OPEC (Organization of the Petroleum Exporting Countries) supported crude prices.

Health care stocks bounced back strongly amidst stock-specific progress and a growing acknowledgment of the sector's discounted valuations and defensive characteristics. A less welcome new development was the downturn in recently solid European bank shares, and the broader European market, as concerns about Italian politics and softer regional growth intensified.

QUARTERLY INVESTMENT MANAGER'S REPORT

QUARTERLY PERFORMANCE ATTRIBUTION

The portfolio underperformed its benchmark for the quarter. A downturn in European bank shares detracted from relative returns in the financials sector. Investor concerns about the combination of Lega and the Five Star Movement to form a populist Italian government and somewhat weaker economic releases intensified during the quarter; however, after reducing exposure to European financials amid last year's strength, we have viewed the recent volatility as a selective buying opportunity.

Stock selection in the health care sector supported relative fund returns. Within the health care sector generally, we have focused on concentrating the portfolio among our highest conviction holdings, which tend to fall into one of two categories: 1) the very cheapest companies with stock-specific issues, and 2) stable companies that have de-rated more moderately due to macro challenges like generic competition and pricing pressures. We have been encouraged by the progress Israeli generic drug maker Teva Pharmaceutical Industries is making under its new chief executive officer's restructuring plan, which seeks to refinance and pay down debt, renew the focus on profitability and deliver US\$3 billion in savings by 2019. The stock could find additional support following a major vote of confidence from Warren Buffett's Berkshire Hathaway, which recently doubled its stake in the firm.

An overweighting and stock selection in the energy sector also boosted results. Energy stocks accounted for several of the portfolio's top 10 contributors, namely UK integrated oil and gas firms BP and Royal Dutch Shell, as well as US exploration and production firm, Apache. Within the energy sector more broadly, we have continued to manage the commodity cycle by selling into the strength of higher-beta oil services stocks as the price of crude rises while maintaining or increasing exposure to high-quality integrated oil producers with the potential for further multiple expansion as new-found capital discipline generates the cash flows required to sustain generous dividend payouts. We think oil price upside potential is limited from current levels given mounting pressures on OPEC—and rising incentives for shale producers—to expand supply. However, material downside potential also appears limited given ongoing growth in global demand for oil.

Stock selection and an underweight allocation in the information technology sector curbed relative results, pressured by the shares of US telecom equipment firm CommScope, which declined after pricing pressures negatively impacted the company's margins. While aggressive pricing from US telecom carriers embarking on large-scale projects has pressured CommScope's profitability, the resulting single-digit hit to near-term free cash flow guidance did not justify the significant share-price selloff, in our view. CommScope has remained a leading global franchise in the solidly growing wireless equipment space (with a #1 or #2 position in most product areas), and the recent pricing concessions have provided the company with solid shares of new, long-term projects. We remain sceptical about the sustainability of tech's outperformance more generally given that recent strength has been driven primarily by multiple expansion, not earnings growth. Indeed, the price-to-sales ratio for the S&P 500 Information Technology Index has almost doubled over the past five years while trend earnings growth has moderated. We cannot explain why contracting growth is being rewarded with an expanding multiple, and we have continued to underweight the sector amidst what appears to be the biggest divergence between tech valuations and fundamentals since the late 1990s.

INVESTMENT OUTLOOK

Looking ahead, we remain optimistic on the prospects for value and believe that companies whose fundamentals are underappreciated by a market focused on the short term should be well positioned for outperformance over time.

Despite our conviction in value's long-term prospects, we are not sitting idly by waiting for the cycle to turn. We have worked hard to continuously refine and improve our process with recent initiatives, including enhanced quantitative capabilities, improved risk management strategies, and the integration of ESG (environmental, social and governance) analysis into our investment framework.

The goal of these efforts is to ensure that our investment process remains true to Templeton's time-tested fundamental value approach while also evolving to best address client goals and market conditions.

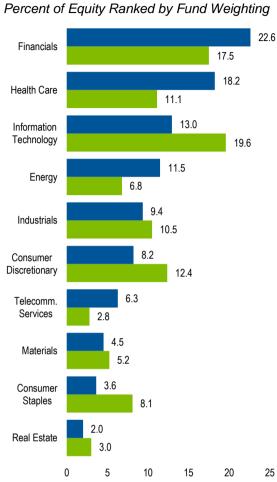

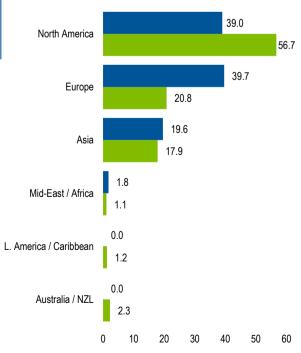
