### **End of Voluntary Escrow Period**

Further to the Company's announcement dated 30 July 2018, Voluntary Escrow Shares held by entities associated with Ruslan Kogan and David Shafer have now been released.

Due to Mr Kogan's relevant interest in Kogan.com Limited by virtue of Section 608(3)(a) of the Corporations Act 2001, Mr Kogan was deemed to have an interest in all the Shares that Kogan.com Limited had the power to control the disposal of, being all the shares subject voluntary escrow arrangements.

As a result of the end of voluntary escrow period, Kogan.com Limited no longer has the power to control the disposal of any Shares held by entities associated with Ruslan Kogan and David Shafer and Mr Kogan no longer has a relevant interest in any Shares held by Shafer Corporation Pty Ltd ATF the Shafer Family Trust.
