Mr Reynolds brings to Golden Mile Resources a strong combination of technical, commercial, project development and executive management capabilities.

The Company would like thank Mr Timothy Putt, a founding and executive director of the Company, for his contribution to Golden Mile's success, including listing the Company on the ASX in June 2018 and the identification of the Company's flagship Quicksilver Nickel-Cobalt project. Mr Putt retires from the Board but will remain with the Company over the coming months to ensure a smooth transition of the Company's operational activities.

The Company would like to thank Dr Koon Lip Choo, a founding director, as he also retires from the Board to pursue other business opportunities.

Golden Mile looks forward to working with Mr Reynolds as he takes up the position of Managing Director on the 23rd of September 2018, and to the expertise he brings to the Company and our project portfolio.
