The monthly NTA is cum dividend, and has not been impacted by the dividend declared of 8.0 cents per share.

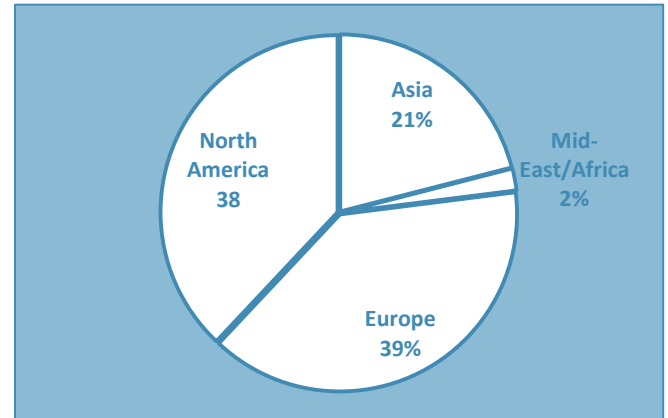

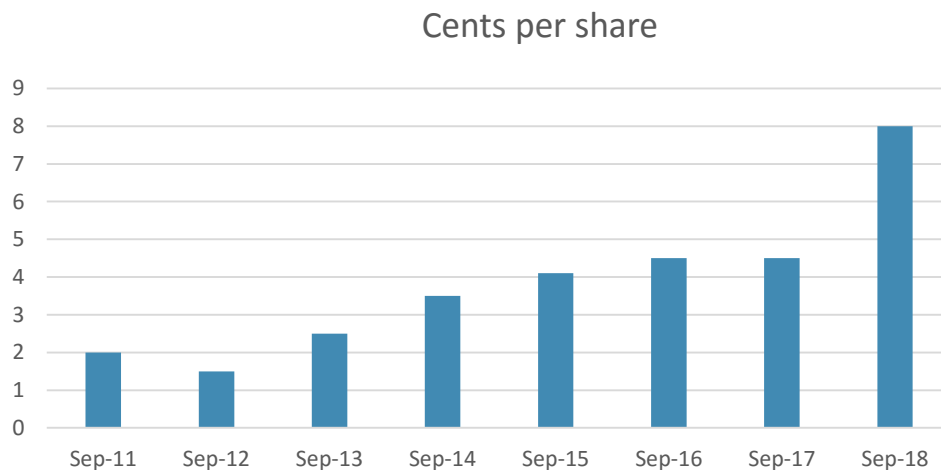
