### Federal Court Action

The second paragraph of DomaCom's ASX/Media Release dated 24 September 2018 headed "*Conclusion of Federal Court Action*" stated that the ATO had until 7 September 2018 to file an application for special leave to the High Court. The ATO and DomaCom, based on their respective interpretations of the word 'judgment' in Rule 41.02 of the *High Court Rules 2004*, disagree about the date by which the Commissioner is required to file an application for special leave to the High Court of Australia. The ATO's view is that the Commissioner has until 16 October 2018 to file an application for special leave. A copy of Rule 41.02 may be viewed at the following link:
