CAPITOL ACQUIRES TWO ADDITIONAL CLINICS IN WA

- Capitol is acquiring an additional 2 clinics positioned in the South-West growth corridor of WA
- Well-established clinics in Eaton and Busselton
- Network represents further geographic expansion into attractive WA market

Capitol Health Limited (Capitol or the Company) (ASX: CAJ) is pleased to announce the acquisition of a further 2 clinics in South West WA, which trade under the name "West Coast Radiology" and service the high-growth area surrounding Eaton (close to Bunbury) and Busselton.

West Coast Radiology provides general diagnostic and interventional services to 2 significant country population centres. Both clinics are comprehensive and offer a full range of services.

Aggregate acquisition consideration is \$5 million upfront on a cash and debt free basis and up to an additional \$0.3 million payable under earn-out over the first year of ownership (based on performance).

The new clinics are expected to contribute \$4.2 million in revenue and up to \$0.9 million in EBITDA on an annual basis (based on FY19 forecast). The acquisition is expected to complete in Q2FY19 (subject to satisfaction of standard conditions). The vendor has agreed to an employment agreement for a period of at least 1 year from completion. Following completion of the acquisition of the West Coast Radiology business, the WA network will have 8 clinics which are all positioned in key growth areas.

Managing Director, Andrew Harrison stated, "Capitol continues on its growth path in the WA market. Within the network of 8 clinics there is potential for new MRI licenses under the Governments new license allocation process because of the location and composition of patients and referrers at these clinics. We expect to see further organic and transactional growth opportunities in the WA market."

The acquisition will be funded from existing cash reserves and facilities.
