



Heads of Agreement for Expansion of Oral Devices into China and Asia

Pace has significant existing on-the-ground operations spanning the Territories and is aligned with various sporting organisations and teams and also has a significant footprint in the pharmacy retail sector. Pace CEO, Gavin Parry, originally from Australia, residing in Hong Kong since 2000 has diverse business experience and is also an advisor to the AFL Asia League Board.

Under the proposed agreement, Pace will:

• market, promote and sell Gameday Mouthguards, The Knight Guard, The Sleep Guardian and Instant Teeth Whitening products in the Territories

while IHL will:

- Retain ownership of all intellectual property including brands and manufacturing processes
- Retain control of all digital marketing platforms for the products and brands
- Manufacture the dental devices through dental laboratories in Shenzhen, China.

This represents a major international expansion opportunity for IHL.

We're delighted to kick off this exciting relationship now, prior to the peak sales season, being the March and June quarters.

This HoA is the second move in as many weeks, expanding IHL's reach into major international markets and follows our licensing of proprietary technology for the creation of cannabinoid medicine, Dronabinol, in the key Territories of the USA, Canada, Australia and New Zealand to create a global multi-faceted business".
