ISSUE OF NEW SECURITIES TO EMPLOYEES Appendix 3B – Application for Listing of Shares

The XTEK Board has recently completed a review of staff incentive remuneration arrangements for 2018 and as part of this process, has approved the issue of new securities to employees of the Company.

The Company advises that in accordance with Section 708 (12) of the Corporations Act, 232,228 new securities have been issued to employees. This is inclusive of issues made to related parties as approved at the Annual General Meeting of shareholders held on 23 November 2018.

Pursuant to the application for official quotation of these new securities, XTEK confirms the following:

- 232,228 new ordinary shares have today been allotted, issued and entered into the Company Register. Holding statements will be dispatched on 24 December 2018.
- The issued capital of XTEK now comprises 40,579,906 fully paid ordinary shares
- For the purposes of ASX Listing Rule 3.10.3, the Company advises that the issue price for the new securities has been set at \$0.395 per share.

Attached is an Appendix 3B which provides details on the issue and seeks for these new securities to be listed as fully paid ordinary shares in the issued capital of the Company.
