Capital Raising Update, Section 708A Cleansing Notice and Appendix 3B

Auctus Alternative Investments Limited [ASX:AVC] (**Auctus or the Company**) is pleased to advise that further to the Company's ASX announcement dated 12 December 2018, the Company has now received all binding commitments from the Tranche 1 Capital Raising noted in that announcement.

To date, a total of 1,220,275 fully paid ordinary shares have been issued pursuant to this capital raising with the remaining shares proposed to be issued over the coming weeks.


