



Blend and Pack Successfully Renews its CNCA accreditation for Export of Infant Formula to China

- **Blend and Pack Pty Ltd (B&P) has successfully renewed its Certification and Accreditation Administration of the Peoples Republic of China (CNCA) for the manufacture of Infant Formula.**
- **B&P is Australia's largest independent manufacturer of nutritional dairy products and one of 15 CNCA accredited for infant formula in Australia.**
