NEW ISSUE OF SHARES GLOBAL HEALTH LIMITED

Further to the Company's announcement on 30 July 2015, the fourth and final payment in respect of the acquisition of the medical software and associated assets of Abaki Pty Ltd has been paid.

The payment consisted of \$32,500 in cash and 208,333 fully paid up ordinary shares as set out in the attached Appendix 3B.

Also, further to the Company's announcement on 18 January 2016, the restrictions in relation to 40,000 unlisted ordinary shares held under the Company's Exempt Employee Share Plan ceased in January 2019. Accordingly, the Company applies for these shares to be listed.
