REQUEST FOR TRADING HALT

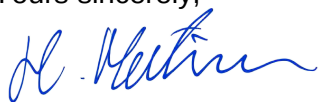
Pursuant to ASX Listing Rule 17.1, P2P Transport Limited (ASX: P2P) (**P2P**) requests an immediate trading halt be granted by ASX Limited (**ASX**) with respect to its Fully Paid Ordinary Shares.

The trading halt is requested in connection with the preparation of the Quarterly Cashflow Statement (Appendix 4C) and a trading update.

The following information is provided in accordance with Listing Rule 17.1:

1. **Reason for trading halt** – To avoid trading on an uninformed basis.
2. **Duration of the trading halt** – P2P expects the trading halt will last until the announcement to the ASX of the Quarterly Cashflow Statement (Appendix 4C) and a trading update.
3. **Termination of the trading halt** – P2P anticipates the trading halt will cease upon the release of an announcement by the Company or the commencement of trading on Tuesday, 23 April 2019.
