Mr Wiadrowski is currently a Non-Executive Director and Chair of the Audit and Risk Committee of ASX listed Vocus Group Limited and holds the same roles on the board of Life360 that will list on the ASX on 10 May 2019. Mr Wiadrowski was previously a Non-Executive Director of the Elevacao Foundation, established to support and mentor early stage female technology entrepreneurs; and a Board Member of PwC Securities and PwC Indonesia.

carsales Chair, Pat O'Sullivan commented on the appointment "We are very fortunate that David has agreed to join the carsales Board. David has the strong background in finance and audit desirable for a Chair of an Audit Committee, as well as extensive experience in the technology space. I am confident that he will make a valuable contribution to the Board as a whole, and my fellow Directors and I are looking forward to working with David in his new role."

The position of Chair of the carsales Audit Committee became vacant when previous Committee Chair Mr O'Sullivan accepted the position of Chair of the Board of Directors in November 2018. In the interim, Non-Executive Director Edwina Gilbert acted in the position pending a permanent appointment.

Mr Wiadrowski holds a Bachelor of Commerce from the University of NSW, is a Graduate of the AICD's Company Directors Course and is a Fellow of the Chartered Accountants of Australia and New Zealand.

Mr Wiadrowski brings the number of carsales directors to seven.
