Change in Director's Interest in Lion Selection Group Limited (LSX)

On 21 May 2019 certain directors of LSX and Lion Manager Pty Ltd increased their holdings in the Company by way of on-market purchase.

Following these recent transactions, direct and indirect ownership of LSX by LSX board and management has increased to a total of 18.72%.

The transactions were:

- purchase by Robin Widdup of 937,500 LSX at 32cps;
- purchase by Chris Melloy of 156,250 LSX at 32cps;
- purchase by Lion Manager Pty Ltd of 625,000 LSX at 32cps.

Robin Widdup has a 40% ownership of Lion Manager Pty Ltd and as such, in accordance with section 608 of the Corporations Act 2001, he is deemed to hold 100% of the shares purchased by Lion Manager Pty Ltd.

Lion Manager Pty Ltd intends to make a distribution of the 625,000 LSX to its ultimate shareholders.
