Trading Halt Request

Pursuant to ASX Listing Rule 17.1 Impression Healthcare Limited ("the Company") (ASX code: IHL) requests that an immediate trading halt be put on its securities, pending an ASX announcement.

In accordance with LR 17.1, the Company advises:

- a) The trading halt is sought to allow finalisation of a significant development in respect of the Company's medicinal cannabis clinical trials.
- b) The trading halt is to last until the earlier of the Company releasing an announcement or the commencement of trade on Monday, 3 June 2019. We expect that the trading halt will be ended by the Company making an announcement of the kind referred to above; and
- c) The Company is not aware of any reason why the trading halt should not be granted or of any other information necessary to inform the market about the trading halt.
