EXPIRY OF LISTED OPTIONS

We are writing to you as a registered holder of STIO listed options in Spirit Telecom Limited to remind you that the options will expire at 5:00pm (AEST) on Wednesday, 31 July 2019.

Your option holding may be exercised in <u>whole or in part</u> by payment of \$0.19688 (19.688 cents) for each option by no later than 5:00pm (AEST) on Wednesday, 31 July 2019. If payment is not received by 5:00pm (AEST) on Wednesday, 31 July 2019 the options will lapse and all rights under the options will cease at that time.

Some of the courses of action available to you as a holder of these soon to expire options are:

- a) Exercise the options on or before 5:00pm (AEST) on Wednesday, 31 July 2019.
- b) Sell your options. Quotation of the options will cease at the close of trading on Thursday, 25 July 2019
- c) Do nothing (i.e. allow your options to expire). If you do not exercise or sell your options they will expire at 5:00pm (AEST) on Wednesday, 31 July 2019 and your right to subscribe for ordinary shares in Spirit Telecom Limited at \$0.19688 (19.688 cents) per share will lapse.

During the three (3) months preceding the date of this notice:

- the highest market sale price of ordinary shares on ASX was \$0.26 (26 cents) on 26 June 2019; and
- the lowest market sale price of ordinary shares on ASX was \$0.12 (12 cents) on 2 April 2019

The Company announced on 31 May 2019 that Shaw & Partners Limited will underwrite all of the 28,732,256 Listed Options (STIO) currently on issue. This means that any shortfall in the exercise of options will be satisfied by way of underwriter take up, subject to straight forward conditions precedent for an underwriting agreement of this nature, further details of which are contained in the ASX announcement on 31 May 2019.
