The company has loan facilities in place with banks in Italy, Israel, Brazil and Argentina with interest rates varying from 1.7% to 3.1%. The majority of these loans are unsecured. The company has bank guarantees in place in Italy and Israel. Approximately \$0.6m of these bank guarantees are secured and the interest charges for these guarantees vary between 1.5% and 2.5% of the guaranteed amount per year.

In March 2019, the Company drew down for the first time on its US\$50 million non-recourse debt facility with Generate Capital which was put in place to fund its Build, Own, Operate & Transfer (BOOT) projects. The facility includes customary terms for such non-recourse financing facilities (including variable interest rates) based on the scope and location of specific project.
