NEW SHARES ISSUED ON CONVERSION OF CONVERTIBLE NOTES AND SECTION 708A(5)(E) NOTICE

SECOS Group Limited ("SECOS" or "the Company") has issued **7,094,575** fully paid ordinary shares ("Shares") to convertible note holders on **16 August 2019** pursuant to Convertible Notes Deed entered into on 30 June 2018.

Consequent to these conversions, group borrowings is now \$1.3 million.

The issue of the Shares was approved by shareholders at the Annual General Meeting held on 30 November 2018 (Resolution 7). The shares are issued at an issue price of \$0.04/share. The share issue price was based on the price of recent share placement price pursuant to Convertible Notes Deed.

In respect of the issue of shares, the Company gives notice pursuant to section 708A(6) of the *Corporations Act* 2001 (Cth) ("Corporations Act") that:

- (a) the Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
