Section 708A Cleansing Notice

This notice is given by engage:BDR Limited (**Company**) under Section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**).

The Company hereby confirms that:

- (a) it has issued 12,397,104 fully paid ordinary shares (**Shares**) on 30 August 2019 for settlement of creditor balances at a deemed issue price of \$0.03 (3 cents) per Share.
