Further to our disclosure letter dated 26 August 2019 with respect to LMR Partners LLP, its affiliates and associates' ("LMR") long exposure in Ruralco Holdings Limited ("Ruralco") via cash-settled contract-for-differences ("CFD") held with UBS AG, we are now writing to notify you, pursuant to *Guidance Note 20: Equity Derivatives paragraph 26b*, that LMR's long exposure to Ruralco totalled 9,410,848 shares as of 3 September 2019, equating to 8.96% of Ruraclo's shares following a sell order of 545,375 shares on the same day.

Please refer to "Appendix 1 - RHL Trading History" for LMR's trading in Ruralco since its initial purchase on 27 February 2019. As noted in our previous letter, the CFD are the totality of LMR's exposure to Ruralco and they carry no voting rights.

LMR consents to Ruralco releasing the information contained in this letter to the market and Australian Securities Exchange. Please provide confirmation to us, once this has been released to the market.
