Notice of Ceasing to be a Substantial Holder


Dear Sir/Madam

I have received advice that my previous disclose of a relevant interest in CAT shares held in the two trusts is no longer accurate. As I do not control the trustee or have the capacity to determine the outcome of decisions about their financial and operating policies, I have amended the basis for calculation of my interests.
