The Wilson Asset Management Group <u>does not beneficially own, and exerts no control or influence over,</u> the HHY Fund (ASX: HHY) shares in which members of the Wilson Asset Management Group are determined to hold an indirect deemed relevant interest in, in accordance with Section 671B of the Corporations Act 2001. As detailed in the enclosed notice, members of the Wilson Asset Management Group are deemed to hold an indirect deemed relevant interest in HHY shares held by Keybridge Capital Limited (KBC). The Corporations Act determine these indirect deemed relevant interests to exist primarily as a result of the members of the Wilson Asset Management Group holding (in aggregate) voting power in excess of 20% in KBC. Members of the Wilson Asset Management <u>do not exert control or influence over KBC</u>.

As a result of this indirect deemed relevant interest, and in accordance with Section 671B of the Corporations Act 2001, please find enclosed a Form 604 - Notice of change of interest of substantial holder in relation to HHY Fund (ASX: HHY). The primary purpose of this notice is to disclose certain indirect deemed relevant interests and voting power that members of the Wilson Asset Management Group are deemed to hold in HHY pursuant to the Corporations Act.
