## Cronos Australia Limited (ASX: CAU) – Admission and Commencement of Official Quotation – Deferred Settlement Trading

### Description

Cronos Australia Limited ('CAU') is expected to be admitted to the Official List of ASX Limited ('ASX') on Thursday, 7 November 2019.

Official quotation of CAU's ordinary fully paid shares is expected to commence at 12:00 AEDT on Thursday, 7 November 2019 on a **deferred settlement basis**.

CAU raised \$20,000,000 pursuant to the offer under its replacement prospectus dated 15 October 2019 ('Replacement Prospectus') by the issue of 40,000,000 ordinary fully paid shares at an issue price of \$0.50 per share.
