Notes

1. The substantial holders were only recently informed of the total number of ordinary shares on issue (as at various dates) from the Company on 1 November 2019. The Company advised that the total number of shares on issue as at 24 October 2019 was 108,011,373 ordinary shares due to capital raisings that the substantial holders did not participate in, which resulted in a dilution of the substantial holders' voting power in the Company.
