## Scheme not proceeding following results of scheme meeting

Australian Unity Investment Real Estate Limited (**AUIREL**), as Responsible Entity of Australian Unity Office Fund (ASX: **AOF**), announces that the trust scheme pursuant to which CHAB Office Pty Limited acting as trustee for the CHAB Office Trust (**CHAB**) would have acquired all the issued units in AOF (**Scheme**) will not proceed.

The Scheme will not proceed given AOF unitholders have only passed Resolution 2. For the Scheme to proceed both Resolution 1 and Resolution 2 needed to be passed because those resolutions were interdependent.

The resolutions were:

Resolution 1: Amendments to the Constitution – not passed by the requisite majority.

Resolution 2: Approval of the Scheme – passed by the requisite majority

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the *Corporations Act 2001* (Cth), details of the total number of votes cast on the polls and the total number of proxy votes are attached to this announcement.
