# 18 November 2019 Board Changes

Eagle Health Holdings Limited (ASX: EHH) ("Eagle Health" or "Company') advises that the Company's Non-Executive Chairman the Hon. Andrew Thomson, Non-Executive Director Mr Rodney Hannington and Company Secretary Mr Kobe Li have resigned effective today, 18 November 2019.

The Company has appointed Dr Brendan James De Kauwe as Non-Executive Director and Mr Henko Vos as Company Secretary, effective today, 18 November 2019. Further, the Company has appointed Mr Andrew Smith as the interim Chairman of the Board.

Dr de Kauwe studied a Bachelor of Science in Pharmacology and Physiology and a Bachelor of Dental Surgery from the University of Western Australia, with Post Graduate certifications in Oral Surgery and Implantology.
