November 2019 Trading Update; Record Revenue Month Since ASX Listing

Highlights

- EN1 achieves its strongest revenue month since ASX listing
- Consolidated revenue up 315% year over year (November 2018) to A\$2.36M
- Q4 2019 revenue up 273% over Q4 2018, month to date
- Q4 2019 revenue up 142% over Q3 2019, month to date
- Revenue growth 17%, over October 2019
- Consolidated revenue total year to date about A\$15.4M
- EN1 has exceeded 2018 revenue by ~A\$4M as at 30 November 2019; 135% (not including December 2019)

engage:BDR ("EN1 or Company") (ASX:EN1 and EN1O) is pleased to present shareholders with a trading update and commentary for November 2019 financial performance with a comparative analysis of the prior year, same period.

November revenue grew to A\$2.36M, about 17% greater than the previous month. Revenue for the year totaled to about A\$15.4M as at 30 November 2019, about 135% of 2018 total revenue (not including December 2019).


