APN Property Group (ASX: APD) – Admission to the Official List of APD Trust and Commencement of Official Quotation of Stapled Securities

Description

APN Property Group Limited is currently admitted to the Official List of ASX Limited ('ASX') and its fully paid ordinary shares trade under the ASX code APD.

On 20 November 2019, shareholders in APD approved the resolutions necessary for fully paid ordinary shares in APD to be stapled to an ordinary unit on a 1:1 basis in a newly formed unit trust registered as a managed investment scheme ('APD Trust'), forming stapled securities ('Stapled Securities') in a stapled entity.

APD Trust is to be admitted to the Official List of ASX on Tuesday, 10 December 2019. The new stapled entity will trade as APN Property Group.

Official quotation of the Stapled Securities is to commence on a deferred settlement basis as part of Group 1 at 10:00:00 am (+/- 15 seconds) AEDT on Tuesday, 10 December 2019.
