Think Childcare Group (ASX: TNK) – Admission to the Official List of Think Childcare Development Limited and Commencement of Official Quotation of Stapled Securities

Description

Think Childcare Limited ('TNK') is currently admitted to the Official List of ASX Limited ('ASX') and its fully paid ordinary shares trade under the ASX code TNK.

On 5 December 2019, shareholders in TNK approved the resolutions necessary for fully paid ordinary shares in TNK to be stapled to fully paid ordinary shares on a 1:1 basis in Think Childcare Development Limited ('TND'), forming stapled securities ('Stapled Securities') in a stapled entity.

TND was admitted to the Official List of ASX on Monday, 23 December 2019. The new stapled entity will trade as Think Childcare Group.

Official quotation of the Stapled Securities will commence as part of Group 5 at 10:09:00 am (+/- 15 seconds) AEDT on Tuesday, 24 December 2019.
