ASX ANNOUNCEMENT

Notice in Respect of Share Issue

Dart Mining NL (“Dart”) has issued 5,400,000 fully paid ordinary shares with a free unlisted option for every two shares issued under the placement as announced on 20 December 2019. The fully paid ordinary shares were issued at 10 cents per share and the free unlisted options are exercisable at 25 cents and expire 30 June 2021. This placement raised \$540,000. A broker was not engaged for the placement.

In accordance with the requirements of section 708A(6) of the Corporations Act 2001 (Cwlth) (“Corporations Act”), Dart notifies ASX Limited that:

- (a) The Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
