LiveHire Limited (ASX: LVH) (“LiveHire” or the “Company”) today announces that it has converted 306,422 unlisted performance rights (“Performance Rights”) into that number of fully paid ordinary shares (“Shares”) after the satisfaction of the relevant vesting conditions applicable to those Performance Rights.

Additionally, the Company gives notice that 55,233 Performance Rights have lapsed due to failure to meet vesting conditions.
