Carbon Revolution (ASX code: CBR) Placement Completion

Carbon Revolution Limited (ASX: CBR) is delighted to announce that settlement of its \$25 million placement, announced on 18 March 2020, has completed with the final \$5.794m in funds being received on 23 March 2020 as foreshadowed in the Company's announcement this morning. A further Appendix 2A in relation to the final settlement is attached.

The placement, which was supported by many of Carbon Revolution's existing institutional shareholders, was undertaken to position the company as strongly as possible to deal with the uncertainty and potential impact on the business associated with the COVID-19 virus outbreak.

Following the completion of the placement the pro forma net cash position of the Company is now approximately \$50.5 million. This places the Company in a strong position to manage through the uncertainties posed by the COVID-19 outbreak and continue to grow into the future.

The Company confirms that production is continuing at its Waurin Ponds facility, and despite various announcements by global OEMs that they are temporarily shutting down production plants, Carbon Revolution's customers continue to expect deliveries of wheels from us on our usual cycle.

Carbon Revolution will also offer existing eligible shareholders the opportunity to participate in a non-underwritten Share Purchase Plan ("SPP"), subject to an aggregate cap of \$3 million. Further details of the SPP are expected to be announced on Wednesday, 25 March 2020.
