Allotment Completed for Entitlement Offer

The Reject Shop Limited (ASX:TRS) ("**The Reject Shop**" or the "**Company**") is pleased to confirm that it has completed the allotment of shares pursuant to The Reject Shop's traditional non-renounceable pro-rata entitlement offer ("**Entitlement Offer**") as announced on 27 February 2020 and which closed at 5:00pm (AEDT) on 23 March 2020.

In accordance with the Entitlement Offer, eligible shareholders were entitled to apply for new shares on the basis of 1 new share for every 3.12 existing shares held at the record date of 7:00pm (AEDT) on 3 March 2020. The Entitlement Offer was conducted at an offer price of \$2.70 per share.

The Entitlement Offer was fully underwritten by Ord Minnett Limited.

Ord Minnett confirms that 9,268,474 fully paid ordinary shares have today been issued pursuant to the Entitlement Offer (including the associated sub-underwriting arrangements), raising approximately \$25,024,880 before costs. These shares, which will rank equally with existing ordinary shares in the Company, are expected to commence trading on a normal settlement basis on 30 March 2020 (having already commenced trading on a deferred settlement basis on 24 March 2020). The Company now has 38,176,622 fully paid ordinary shares on issue. An Appendix 2A – Application for Quotation of Securities relating to the securities noted above is attached to this announcement.
