New Programmatic Client Integrations

EN1 recently signed five more **large scale** programmatic partnerships, kiip, Advangelists, PulsePoint and RhythmOne; all are expected to be strong revenue contributors for the EN1 programmatic exchange. All five integrations are now live and in test phases; significant revenue contribution is expected, as the demand and ad opportunities are very unique, non-overlapping with current EN1 business.

Additionally, AdCel on-boarded one of the largest global programmatic buyers – Criteo. To recap, EN1 has on-boarded 7 new programmatic integrations in Q1 2020, exceeding the target of 5 for the quarter; total programmatic integrations are now 225.
