REQUEST FOR SUSPENSION

Pursuant to ASX Listing Rule 17.2, P2P Transport Limited (ASX: P2P) (**P2P** or the **Company**) requests an immediate suspension from quotation be granted by ASX Limited (**ASX**) with respect to its Fully Paid Ordinary Shares.

The following information is provided in accordance with Listing Rule 17.2:

1. Reason for a voluntary suspension

So that the company can take steps necessary to respond to the change in trading conditions and assess the impact caused by COVID-19, including negotiating with various creditors and other third parties.

2. Duration of the voluntary suspension

The Company requests the voluntary suspension remain in place until the earlier of the Company making an announcement to the market or the commencement of normal trading on Wednesday 15 April 2020.
