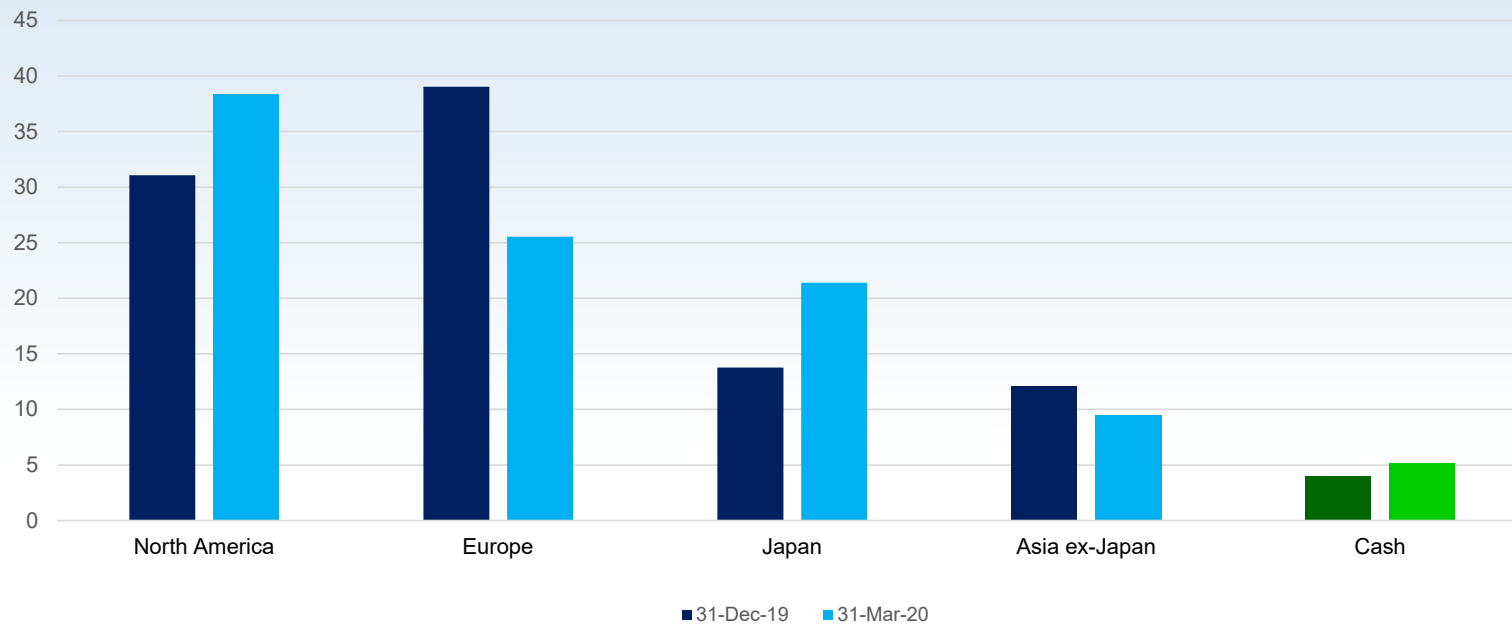

## Country

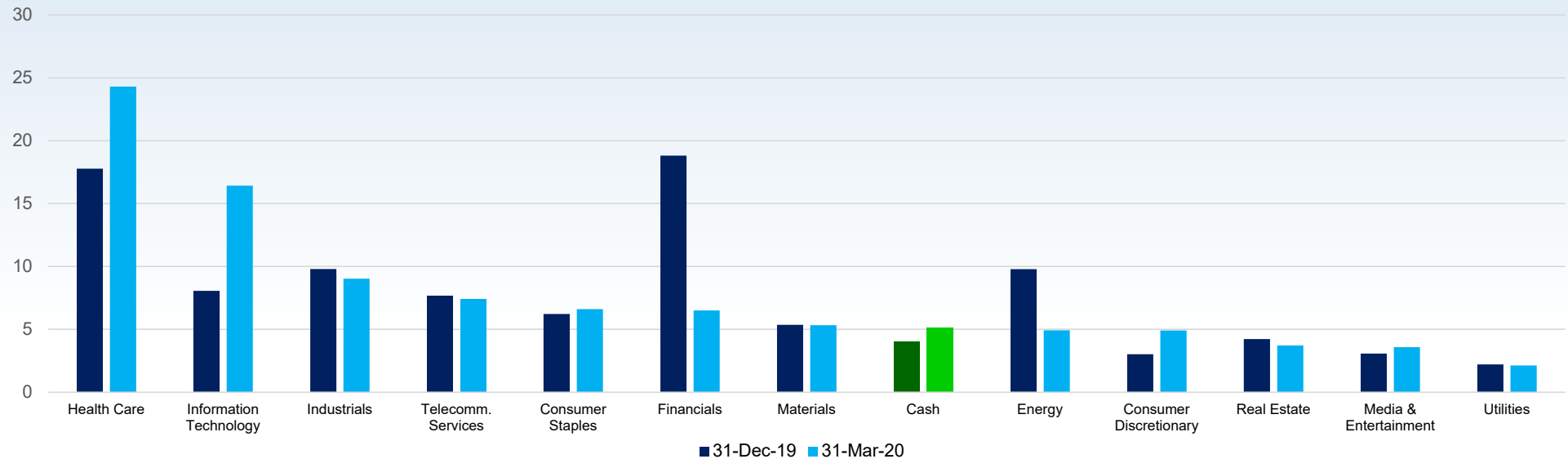
% Portfolio Weights

## Sectors

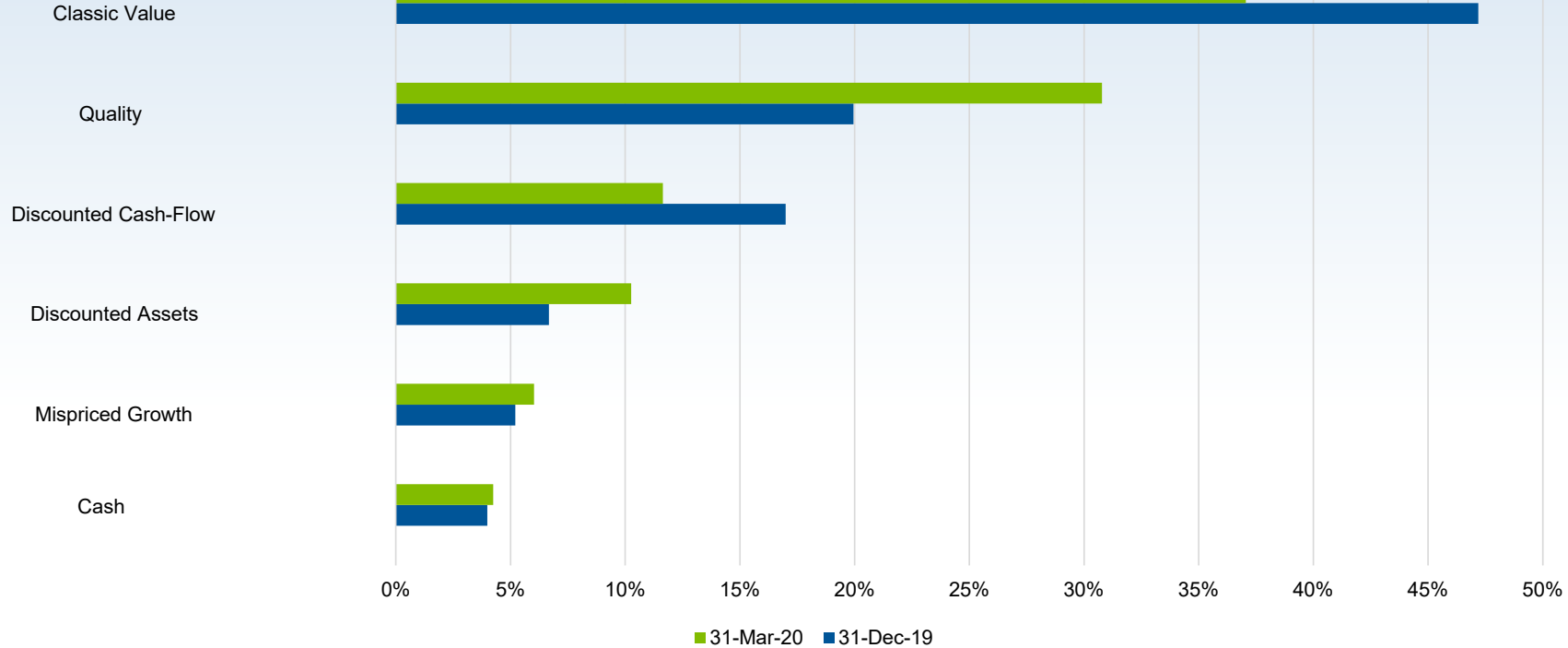
% Portfolio Weights
