Completion of Share Purchase Plan Offer & Appendix 2A

Capitol Health Limited ("Capitol" or "Company") (ASX: CAJ) is pleased to announce the completion of its Share Purchase Plan Offer ("SPP Offer") previously announced to ASX on 14, 16, 17, 21 and 22 April 2020.

The SPP Offer provided eligible shareholders the opportunity to subscribe for up to \$30,000 of fully paid ordinary shares in the Company at an issue price of \$0.16 (16 cents) per share ("Shares"). The SPP aimed to raise up to \$10 million, with the Company having the absolute discretion to increase the size of the SPP or to scale back the applications received.

The SPP Offer was heavily supported by eligible shareholders and the Company received applications well in excess of \$10 million under the SPP Offer. Consequently, in all the circumstances, the Company has decided, in accordance with the terms of the SPP Offer, to set the SPP cap at \$10 million ("SPP Cap") and to scale back the applications received by applying a fixed percentage on each application calculated by reference to the percentage by which the aggregate value of all applications exceeds the SPP Cap. Any excess application monies will be refunded without interest.

The Company would like to express its appreciation to all eligible shareholders who participated in the SPP Offer and thanks shareholders for their continued support. The new shares will be issued to eligible applicants on Wednesday, 20 May 2020, details of which can be found in the attached Appendix 2A. Holding statements will be despatched, and refunds of subscription monies due to the scale back will be made on or around 5 June 2020.
