#### **Employee Share Option Plan Performance Rights**

In **October 2018** the Company announced the grant of a total of 20,165,000 non-listed Performance Rights ("Rights") to persons eligible under the Company's shareholder approved Employee Share Option Plan.

The Rights as granted related to:

- The raising of new equity capital to fund the mining of the Trouser Legs Gold Mine ("TLGM");
- The mining of the TLGM; and
- The identification of JORC compliant gold resource in the Yundamindera Project.

Of the 20,165,000 Rights milestone events attached to 5,530,000 Rights related to the funding and the first delivery of the TLGM ore for processing had been achieved and vested. That vesting left an aggregate of 14,815,000 non-vested Rights related to:

•	TLGM Project	7,650,000 Rights; and
•	Yundamindera Proiect	7,165,000 Rights.

In **June 2019** the Company announced the completion of the sale of the Yundamindera Project tenements thereby rendering as incapable of completion the milestone events related to the identification of JORC compliant gold resource. As such the Project related 7,165,000 Rights were deemed to be and are now formally cancelled.

In **December 2019** the successful mining of the TLGM was completed. Following the finalization of the financial reports/statements for the Project and the receipt of the proceeds from the sale of gold the milestones events related to the 7,650,000 Rights have been declared as having been achieved.

Attached is an Appendix 2A whereby of the vested TLGM Rights a total of 6,900,000 underlying ordinary shares on the basis of one new share for each vested Right are now issued.
