**Notice to ineligible foreign shareholders regarding non-renounceable rights offer**

On 29 May 2020, Pure Alumina Limited (**PUA** or **Company**) announced a non-renounceable pro rata rights offer (**Entitlement Offer**) to acquire three (3) new ordinary shares (**New Shares**) at \$0.009 each for every five (5) existing fully paid ordinary shares held by PUA shareholders in Australia and New Zealand (**Eligible Shareholders**) at 7:00 pm (Sydney time) on Wednesday, 3 June 2020 (**Record Date**). One free attaching new option with an exercise price of 2.5 cents (\$0.025) and expiry date of 30 December 2022 will also be issued for every two New Shares issued. The Entitlement Offer will raise approximately \$1,377,135, before issue costs.

Full details of the Entitlement Offer are contained in the Prospectus lodged with ASIC and the ASX on 29 May 2020, and is available to view on the ASX website under the Company's ASX code "PUA" and PUA's website at [www.purealumina.com.au](http://www.purealumina.com.au).

The Entitlement Offer is currently scheduled to close at 5:00 pm (Sydney time) on Tuesday, 30 June 2020.

The Company has determined that it would be unreasonable to extend the Entitlement Offer to Shareholders with registered addresses outside Australia or New Zealand, having regard to:

- the small number of Shareholders with registered addresses outside Australia and New Zealand;
- the number and value of the New Shares which would be offered to ineligible Shareholders (being International Shareholders); and
- the cost of complying with the legal requirements and requirements of the regulatory authorities, in the respective overseas jurisdictions.

Accordingly, the Entitlement Offer will not be made to International Shareholders. This letter constitutes the notice that the Company is required to give each Shareholder that is not an Eligible Shareholder under ASX Listing Rule 7.7.1(b).
