Section 708A Notice and Appendix 2A

This notice is given by engage:BDR Limited (**Company**) under Section 708A(5)(e) of the *Corporations Act* 2001 (Cth) (**Corporations Act**).

In accordance with the terms and conditions of the Convertible Securities Purchase Agreement (**Agreement**) between the Company and Alto Opportunity Master Fund SPC – Segregated Master Portfolio B (**Alto**), the Company is required to issue replenishment Collateral Shares to Alto. 40,423,775 replenishment Collateral Shares will be issued in accordance with the Agreement.

The Company also today issued 30,000,000 fully paid ordinary shares for settlement of creditor balances.

The Company hereby confirms that:

- (a) On 11 June 2020 it has issued 40,423,775 fully paid ordinary shares to Alto at a deemed issue price of \$0.006 (0.6 cents) per share;
- (b) On 11 June 2020 it has issued 30,000,000 fully paid ordinary shares for settlement of creditor balances at a deemed issue price of \$0.008 (0.8 cents) per Share.
- (c) the shares referred to in paragraphs (a) and (b) above were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
- (d) the Company is providing this notice under paragraph 5(e) of Section 708A of the Corporations Act:
