# COLES to roll out WNB's Jbronze by Jennifer Hawkins Nationally across 800+ stores

Jbronze is expected to be on sale in about 800 COLES stores from mid-August 2020 and the Company expects the brand will achieve annualised sales of over \$2M in FY2021.

Jbronze is proudly Australian made and owned and has a unique proposition of being all natural 100% vegan friendly, and palm oil and paraben free. The current retail range includes 11 products and Australian supermodel Jennifer Hawkins has been intimately involved in the creation of the Jbronze range which includes self-tanning mousses, creams, illuminiser, and oils that are applied to create a sunless golden tan all year.



GBCo currently retails Jbronze via an omnichannel strategy that includes online, in major pharmacy banner groups, and in grocery at Woolworths.

**WNB** Managing Director and Chief Executive Officer Ms Christine Parkes said, "There has been strong growth in the Australian self-tan market in recent years. This has been driven by consumers wanting the look of a golden tan, without exposing themselves to the dangers of extended sun exposure.

"Since Jbronze was launched in the market in 2013, the tanning brand has built a strong retail presence in pharmacy and today's announcement further extends this standing in grocery," Ms Parkes said.

Wellness and Beauty Solutions has a growing portfolio of beauty and wellness products with strong cross promotion across its retail network.
