
The growing market for electronic healthcare software across Victoria

Global Health forecast the market for Victorian Community Health to grow rapidly over the following decade, with Federal and State Governments pushing for a shift from paper-based reporting processes to electronic forms of patient management.

In 2020, eight of the main Government funding programs which Global Health support, totalled approximately \$37.6 billion annually, whilst the five programs adopted by community health organisations such as Ballarat accounted for approximately \$30.5 billion of this funding.
