US Bankruptcy Court order – notice of filing deadline

US Bankruptcy Court enters order establishing deadlines for filing proofs of claim in chapter 11 cases

Sydney, Australia, 8 July 2020 - Speedcast International Limited (ASX: SDA), today announced that in connection with the voluntary restructuring process under chapter 11 of the United States Bankruptcy Code initiated by the Company on 23 April 2020, the United States Bankruptcy Court has entered an order establishing certain deadlines for the filing of proofs of claim on account of prepetition claims in the chapter 11 cases. The deadline, or "General Bar Date," is 6 August 2020 at 5.00pm (prevailing Central Time) for all creditors (other than governmental units). Further information in relation to the order is set out in the notice attached to this announcement.

2. On July 6, 2020, the Court entered an order (Docket No. 463) (the "Bar Date Order")² establishing certain deadlines for the filing of proofs of claim in the Debtors' chapter 11 cases.

3. Pursuant to the Bar Date Order, all persons, entities, and governmental units who have a claim or potential claim, including any claims under section 503(b)(9) of the Bankruptcy Code,³ against any of the Debtors that arose prior to the Petition Date, no matter how

remote or contingent such right to payment or equitable remedy may be, MUST FILE A PROOF OF CLAIM on or before August 6, 2020 at 5:00 p.m. (prevailing Central Time) for general creditors (the "General Bar Date") and October 20, 2020 for governmental units (the "Governmental Bar Date," and together with the General Bar Date, the "Bar Dates"), by (i) filing such Proof(s) of Claim electronically through KCC, at https://kccllc.net/speedcast; (ii) filing such Proof(s) of Claim electronically through PACER (Public Access to Court Electronic Records), at https://ecf.txsb.uscourts.gov; or (iii) mailing the original Proof(s) of Claim to KCC at the following address:

- 4. The Bar Dates apply to all claims against the Debtors arising under section 503(b)(9) of the Bankruptcy Code; <u>provided</u>, <u>however</u>, that the Bar Dates do not apply to the Excluded Claims listed in paragraph 8 of the Bar Date Order.
- 5. ANY PERSON OR ENTITY (EXCEPT A PERSON OR ENTITY WHO IS EXCUSED BY THE TERMS OF THE BAR DATE ORDER) WHO FAILS TO FILE A PROOF OF CLAIM ON OR BEFORE THE APPLICABLE BAR DATE IN ACCORDANCE WITH THE INSTRUCTIONS ABOVE WILL NOT BE TREATED AS A CREDITOR FOR PURPOSES OF VOTING UPON, OR RECEIVING DISTRIBUTIONS UNDER, ANY PLAN OR PLANS OF REORGANIZATION OR LIQUIDATION IN THE CHAPTER 11 CASES.
