Cleansing Statement Notice Pursuant to Section 708A(5)(e) of the Corporations Act

Dotz Nano Limited (the **Company**) (ASX: DTZ) gives notice under section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**) as follows:

- (a) The Company has issued 50,000 fully ordinary paid shares (**Shares**) in the Company at an issue price of \$0.085 (8.50 cents) per Share from the exercise of 50,000 unquoted options (DTZOPT18).
- (b) The Shares rank pari passu with existing Dotz ordinary shares.
- (c) The Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act.
- (d) As at the date of this notice, the Company has complied with:
 - the provisions of Chapter 2M of the Corporations Act, as they apply to the Company; and
 - Section 674 of the Corporation Act.
- (e) As at the date of this notice, there is no 'excluded information' (within the meaning of sections 708A(7) and 708A(8) of the Corporations Act) required to be disclosed under section 708A(6)(e) of the Corporations Act.
